have agreed as follows:

The Agreement No. 451/KSAP/2019 done on the 17th of January 2019 is hereby amended as follows:

1. In Article 2.1 the words '35 months' shall be replaced by '54 months'.
2. In Article 5.1 the amount '181 609,80 PLN (one hundred and eighty-one thousand, six hundred and nine zlotys 80/100)' will be updated after financial settlement of the training in 2023 concerning group number 7 – update based on the actual costs of training already incurred and settled for groups 1-6 and the actual costs of training for group 7, not higher than the costs indicated in Attachment B to this annex.
3. In Article 5.2 the amount '181 609,80 PLN (one hundred and eighty-one thousand, six hundred and nine zlotys 80/100)' will be updated after financial settlement of the training in 2023 concerning group number 7 – update based on the actual costs of training already incurred and settled for groups 1-6 and the actual costs of training for group 7, not higher than the costs indicated in Attachment B to this annex.
4. The Attachment A) (Implementation schedule) shall be replaced by new Implementation schedule attached to this Annex.
5. The Attachment B) (Project budget) shall include budget for the training in 2023 – group 7 attached to this Annex.
6. The remaining terms and conditions of the said Contract are not amended.

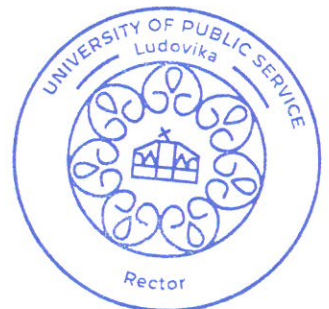
